PRESENTATION DESCRIPTIONS:

DAY 1

FEMA UPDATE

Recently, FEMA Administrator Brock Long laid out three focus areas for FEMA's strategic planning. First, ***BUILD A CULTURE OF PREPAREDNESS*** throughout the Nation. Second, ***READY THE NATION FOR CATASTROPHIC DISASTERS*** by strengthening partnerships. Third, ***REDUCE THE COMPLEXITY OF FEMA***. In his FEMA update, James Joseph, FEMA Region V Administrator will discuss how these focus areas will impact FEMA's Regional support to states and citizens.

2-1-1 & DISASTER RESPONSE

The Ohio Alliance of Information and Referral Services (AIRS) will provide an overview of 2-1-1 in Ohio and how 2-1-1 can assist in local disaster response and recovery.

DRONE INTEGRATION AND DAMAGE ASSESSMENT

The National Weather Service is responsible for conducting storm damage surveys for severe thunderstorms that produce tornadoes. Historically, these surveys have been completed on the ground to assess storm damage, where the storm survey team is tasked to re-create the life of the tornado and document key attributes such as tornado beginning, ending, length, width and maximum rating on the Enhanced Fujita Scale. This presentation will describe the storm damage survey process, and also explore how data from unmanned aerial vehicles can be integrated into a storm damage survey.

EMERGENCY MANAGEMENT AND COMMUNICATIONS WITH THE AMISH COMMUNITY

Amish populations now exist in 44 of Ohio's 88 counties. This panel will explore the challenges and successes of communicating emergency preparedness between local emergency managers and the Amish community. Both Holmes and Ashland counties have developed extraordinary success in this area and will share suggestions and lessons learned on how to develop these critical relationships.

STATE OF THE AMERICAN RED CROSS

The American Red Cross presentation will provide an overview on:

OHIO DAM SAFETY PROGRAM & DAM EMERGENCY ACTION PLANS

All dams regulated by the Ohio Department of Natural Resources (ODNR), Division of Water Resources, Dam Safety Program are required to have a state approved Emergency Action Plan (EAP). Developing an EAP is the responsibility of the dam owner, however many partners play a key role in the event of a dam emergency including the County Emergency Management Agency, ODNR Dam Safety Program, and the National Weather Service. This presentation gives a brief background on dam safety in Ohio and highlights key components for developing an EAP following guidelines from the Interagency Committee on Dam Safety (ICODS).

EMAC – HURRICANE RESPONSE

The Emergency Management Assistance Compact (EMAC) panel will cover the topic from a national perspective (including use of EMAC during the 2016 Republic National Convention and 2017 Hurricane Season) while also drilling down to provide Ohio specific information. Legal matters associated with EMAC as well as the collaboration between Ohio EMA and the National Emergency Management Association (NEMA) will be discussed. Ohio EMA staff will discuss the internal processes followed when EMAC requests are received as well as developing Mission Ready Packages (MRPs) for the EMAC operating system. Ohio and County EMA representatives will discuss EMAC from the standpoint of being deployed and recommendations for submitting reimbursement packets.

KIRKERSVILLE, OHIO SHOOTING: RESPONSE AND LESSONS LEARNED

On May 12, 2017 law enforcement officers responded to a gunman who had tragically taken the lives of the local police chief and two others at a nursing home. This panel discussion consisting of; the County EMA Director, local fire, county sheriff and representatives from the Licking County 9-1-1 center will discuss the response and the lessons that came from it.

OVERVIEW OF THE AMERICAN RED CROSS & MASS CASUALTY PREPAREDNESS

A brief overview of the Red Cross mass casualty response to administrative sites (EOCs, JFSOCs), client Delivery sites (FAC, site visits and memorials), and responder service delivery sites (respite centers, morgue and other body recovery sites). And further, how we prepare Red Cross staff to work in these environments.

2017 LAS VEGAS SHOOTING

Mr. Cage will provide an overview of the 2017 Las Vegas mass shooting event, and discuss preparedness, response, and recovery efforts. He will discuss lessons learned from the event, as well as recommendations to improve policy, budgetary, and operational practices in the future. Following his comments, he will engage in a question and answer period with the audience.
