

Emergency Public Safety and Security

Capability Standard – Intelligence Investigation, Analysis and Production

Capability Definition

The Emergency Public Safety and Security Response capability is intended to reduce the impact and consequences of an incident or major event by securing the affected area, including crime/incident scene preservation issues as appropriate, safely diverting the public from hazards, providing security support to other response operations and properties, and sustaining operations from response through recovery. Public Safety and Security Response requires coordination among officials from law enforcement, fire, and emergency medical services (EMS).

Intelligence Analysis and Production is the merging of data and information for the purpose of analyzing, linking, and disseminating timely and actionable intelligence with an emphasis on the larger public safety and homeland security threat picture. This process focuses on the consolidation of analytical products among the intelligence analysis units at the Federal, State, local, and tribal levels for tactical, operational, and strategic use. This capability also includes the examination of raw data to identify threat pictures, recognize potentially harmful patterns, or connect suspicious links to discern potential indications or warnings.

Desired Outcomes: The desired outcome of this capability is that timely, accurate, and actionable intelligence/information products are produced in support of prevention, awareness, deterrence, response, and continuity planning operations. The incident scene is assessed and secured; access is controlled; security support is provided to other response operations (and related critical locations, facilities, and resources); emergency public information is provided while protecting first responders and mitigating any further public risks; and any crime/incident scene preservation issues are addressed.

The jurisdiction has created and maintains an Emergency Operations Plan and a Resource Manual that:

- Outlines the responsibilities assigned to each organization that has a law enforcement/public safety-related emergency response and/or recovery assignment of responsibility in the plan.
 - Identifies the agencies/positions/titles that will command law enforcement/public safety-related incidents and have overall responsibility to coordinate those response operations.
 - Identifies the actions that will be taken by Law Enforcement personnel to contain and stabilize a disaster (crowd control, hostage negotiation, evacuate areas, collect evidence).
 - Describes the method by which public safety and security resources will be provided to support incident operations, including threat or pre-incident and post-incident situations.

- Describes the process to determine public safety and security requirements and to determine resource priorities.
- Describes the process to maintain communication with supporting agencies to determine capabilities, assess the availability of resources, and track resources.

A fully-functioning Law enforcement Function capability for emergency response operations should address the following measures:

- The jurisdiction’s law enforcement function operations have been established, are maintained in EOP/SOP/SOG, and addresses the following elements:
 - Maintaining law and order
 - Providing security for EOC, incident sites, disaster areas, critical facilities, damaged public property, staging areas and shelter facilities

- Traffic control and road condition levels
 - Crowd control
 - Evacuation
 - Communications and warning
- The jurisdiction has Designated EOC law enforcement services coordinator.
 - The jurisdiction has Developed resource agreements and/or written mutual aid agreements with other government agencies and counties.
 - The jurisdiction has Developed resource agreements and/or written mutual aid agreements with business & industries and contractors.
